Please Note

1. Applicants must be currently registered with the Lakes Trust. This applies to applicants for individual and Family licences.
2. All applications for the licence shall be in writing on an official form available from the Te Arawa Lakes Trust.
3. There will be a ballot for all licences available.
4. The Allocation Model is as follows:
 - Koeke/ Kaihapai – 50
 - Open / Beneficiaries – 150
5. A ballot will be conducted for Koeke/Kaihapai licences in the first instance. Those unsuccessful in this ballot will automatically be transferred into the Open/Beneficiary Ballot
6. Koeke/Kaihapai – Koeke/Kaihapai are those nominated for licences in writing by marae or an Iwi authority in recognition of service to marae. Nominations for this ballot MUST have a letter from marae or an Iwi authority to endorse these specific nominations
7. If applying for the open ballot your application must be signed by a trustee of your Tuupuna rohe
8. For the purposes of ensuring that all allocated licences are taken up, the ballot will be for 230 licences. That is, should a licence not be picked up within a specified period as set out in this policy, the licence will be reallocated to the next person on the list.
9. Applications close on 31 August 2010
10. Successful recipients will be notified by Monday 6 September 2010
